- Emergency Protective Order (EPO), if more restrictive and if same parties
- Any no contact provision in any restraining order, whether criminal or civil
- A criminal protective order (CPO)
- 1 Stalking (Penal Code §646.9) no requirement of a particular relationship
 - Willfully, maliciously and repeatedly following or willfully and maliciously harassing another person, and
 - Making credible threat with intent to place person in reasonable fear for his/her safety or safety of immediate family.
- 2 Cohabitant (Fam Code §6209): Person who regularly resides in household; social unit, not roommates or sub lessees. (O'Kane v. Irvine (1996) 47 CA4th 207)
- **3 Dating relationship (Fam Code §6210):** Frequent, intimate association characterized by expectation of affection or sexual involvement independent of financial considerations.
